NOTICE OF VACANCY Member of the Public

The City of La Verne is currently accepting applications for one (1) vacancy for the following:

LA VERNE PUBLIC FINANCING AUTHORITY ENHANCED INFRASTRUCTURE FINANCING DISTRICT (EIFD)

The La Verne City Council established a Public Financing Authority and created the Enhanced Infrastructure Financing District No. 1 (EIFD). The Public Financing Authority serves as the governing board of the EIFD.

The primary purpose of the Authority is to accelerate the financing of public improvements needed to attract the development that is envisioned within the City's Old Town La Verne Specific Plan and to complement the extension of the Gold Line.

Authority Board – The Board is composed of five members. Two members of the La Verne City Council, one member of the Los Angeles County Board of Supervisors (District 1) or their Alternate, and two public members, one to be appointed by the La Verne City Council and the other to be appointed by the Los Angeles County Board of Supervisors.

Term of Office - Each member will serve at the pleasure of the City Council and shall serve until their successor assumes office.

Qualifications - Applicants must be 18 years old and should have knowledge of finance, banking, and business. Preference will be given to applicants who currently reside or work in La Verne.

Individuals will be selected by a majority of the City Council in a manner similar to the practices used for other City Committees and Commissions.

The Committee falls within the guidelines of the Brown Act (California Government Code §54950, et seq.) and all meetings are open to the public. In addition, members are required to file Conflict of Interest Statements on an annual basis.

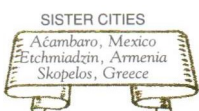
The closing date for submitting applications is Thursday, October 5, 2023, at 6:00 p.m.
