The City Council will meet for the following:

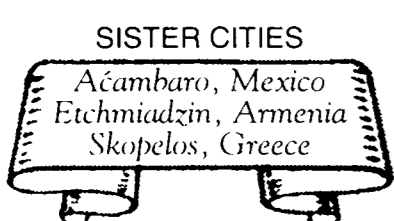
1. City Manager and Department Heads will give City Council an update on the City response, activities, and changes in services related to COVID-19.
2. City Council consideration of Urgency Ordinance No. 1093, Temporarily Prohibiting the Eviction of Residential and Commercial Tenants for Non-Payment of Rent Caused by the Coronavirus.
3. City Council is requested to appropriate \$50,000 from the City's General Fund Reserves in support of City's activities regarding COVID-19.
4. Request the City Council to temporarily waive late fees associated to payment for all municipal services that have occurred from March 4, 2020, through April 30, 2020.
5. In compliance with the County Health order that operations be limited to essential services only; request the City Council to confirm the extension and full pay and benefits of city employees constituted as non-essential that are requested to work a modified schedule or be on-call as needed.

Said meeting shall be held to conduct the above-stated business and no other matters.
