NOTICE OF PUBLIC HEARING BEFORE THE PUBLIC FINANCING AUTHORITY OF THE CITY OF LAVERNE ON MAY 6, 2020

NOTICE IS HEREBY GIVEN that the Public Financing Authority will conduct a public hearing on Wednesday, May 6, 2020, at 9:00 AM, at La Verne City Hall, 3660 "D" Street, La Verne on the following matter:

The City of La Verne has initiated a process to re-establish an Enhanced Infrastructure Financing District (EIFD) near the City's future Gold Line light rail station. The District is made up of properties located in two different areas: 1) properties south of Arrow Hwy., west of Wheeler Ave., north of Puddingstone Dr., and east of the Puddingstone Channel; and 2) properties on First St. and Arrow Hwy. between E St. and White Ave., and south of Arrow Hwy. and east of White Ave. Similar to former Redevelopment areas, the purpose of an EIFD is to direct future property taxes to pay for identified infrastructure improvements in these areas. Once re-established, a portion of the property tax increment that the City of La Verne and County of Los Angeles receives would be specifically restricted to pay for the 14 identified infrastructure projects listed in the Infrastructure Financing Plan (IFP) at an estimated cost of \$33 million. These infrastructure improvements include utility upgrades, undergrounding of overhead utilities, street improvements, pedestrian connectivity, and landscape and lighting upgrades.

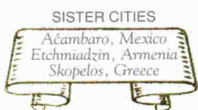
This project is exempt from environmental review per Sections 15378(b)(4) and 15061(b)(3) of the California Environmental Quality Act. No further environmental review is required at this time. Written comments should be received before May 6, 2020. Comments should be sent to: Community Development Department, 3660 "D" Street, La Verne, CA 91750, Attn: Eric Scherer.

Pursuant to Government Code Section 65009 (b), if this matter is subsequently challenged in Court, the challenge may be limited to only those issues raised at the public hearing described in this notice or in written correspondence delivered to the City of La Verne at, or prior to, the public hearing.
