Said public hearing will be held for Council to consider the following matter:

A Request to appeal the Planning Commission approval of Case No. 96-20CUP The Fountains RV Storage expanded storage lot.

The City of La Verne received a request to appeal the Planning Commission's decision to approve The Fountains proposal to expand their recreational vehicle (RV) storage lot located at 3530 Damien Avenue. The Planning Commission approved the proposal by a 4-0, which would allow them to expand their original RV storage lot from 40 spaces to 67 spaces. The RV storage lot will also be screened by landscaping on a 13' foot easement abutting Damien Avenue.
